

# Regulations for Rohan 2023 Scholarship

## I. OBJET

The Institut français d'Autriche and the Ministry of Europe and Foreign Affairs grant "Séjour Scientifiques de Haut Niveau" scholarships for short stays in France. In Austria, these grants are also available in the cultural field. Thus, the cultural service of the Institut français d'Autriche awards a grant worth € 1700 (one thousand seven hundred euros) to an artist with a research and/or creative residency project of one to three months in France in 2023.

This year, the focus is on photography, literature or translation. The grant will be awarded to a project in one of these three disciplines.

## II. RECIPIENT

The grant is awarded to an artist whose project is part of a residency program within one of the partner structures. The project must be sufficiently mature and well developed. Applicants are expected to have produced several noteworthy works in the discipline for which they are applying.

## III. NATIONALITY AND RESIDENCE

Only artists with Austrian nationality or resident in Austria at the time of application may apply. French nationality (or dual nationality including French nationality) excludes the award of a French government scholarship. Artists who are already in France are not eligible to apply.

## IV. LANGUAGE REQUIREMENTS

Fluency in English and/or French is required to apply.

## V. COMPOSITION OF THE APPLICATION FILE

The application file is composed of the following documents

- Completed and signed application form;
- CV (2 pages maximum, in French or English);
- Description of the research and/or creation project, including the desired residency location(s) (5 pages maximum, in French or English);
- Artistic Portfolio presenting the artist's work (links to websites, video or audio extracts, photographs, press articles, etc.) (5 pages maximum);
- A statement on honour guaranteeing that the works presented are those of the artist;
- If financial support from another institution: letter of commitment from the partner specifying the details and terms of this support.

All documents must be sent to [vienne@campusfrance.org](mailto:vienne@campusfrance.org) (object: "ROHAN\_Nom") before April 30, 2023 (11:59 PM).

## VI. APPLICATIONS EXAMINATION

The French Institute of Austria will first check that candidates meet requirements for registration. Any application that is incomplete or sent after the deadline is considered ineligible.

Eligible applications are examined by a jury composed of the cultural service of the Institut français d'Autriche and representatives of partner host structures. The jury examines the applications, gives its opinion on the quality of the candidates' work and the relevance of their project, and submits its proposals for the winning candidate.

If none of the candidates meet the conditions of previously-enounced rules, the grant may not be awarded.

## **VII. DATES OF RESIDENCY**

The candidate selected to receive the Rohan 2023 Scholarship will be able to start his or her mobility as of July 1, 2023, and must have completed the residency by December 31, 2023 at the latest. The residency must last between 1 and 3 months.

Extension is not automatic. It must be requested from the SCAC of the French Embassy in Austria, which, if accepted, will ask the grant recipient to prepare a new application file.

Any changes in the dates of residence compared to the information given in the application file must be requested from the Institut français d'Autriche, which reserves the right to refuse.

## **VIII. CONDITIONS FOR PAYMENT OF THE SCHOLARSHIP**

As a recipient of a French Government Scholarship, the scholarship holder must contact the Campus France center in his/her region upon arrival in France. He/she will not be allowed to leave the country of residence until he/she is in possession of the CampusPass', which provides information on the services provided by Campus France (amount of the scholarship, housing, insurance, etc.).

The recipient agrees to have a valid identity card and to interrupt any professional activity not directly related to the discipline during the period of stay.

A final report on the residency program should be sent to [vienne@campusfrance.org](mailto:vienne@campusfrance.org). Publications of the recipient's work must mention financial support of the Institut français d'Autriche (logo).

## **IX. SCHOLARSHIPS' COMBINATION**

The Rohan Scholarship cannot be combined with an apprenticeship or work contract, a scholarship from the Ministry of Europe and Foreign Affairs, an Erasmus + scholarship or a scholarship from the Agence Universitaire de la Francophonie. In case of cumulation, the Rohan Scholarship will be automatically cancelled.

## **X. SCHOLARSHIP RENEWAL**

The grant may be awarded to the same artist for a maximum of two consecutive years.

## **XI. EFFECTIVE DATE**

The present rules come into effect on March 10, 2023.
